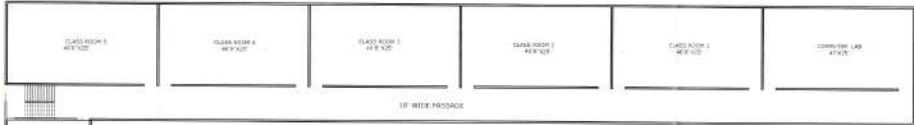

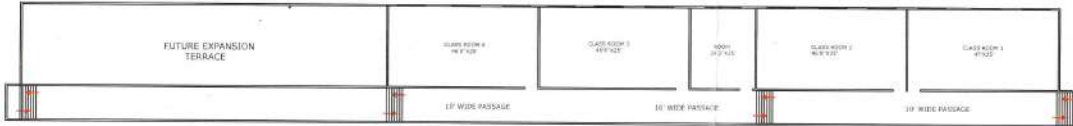
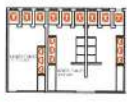
GROUND FLOOR PLAN

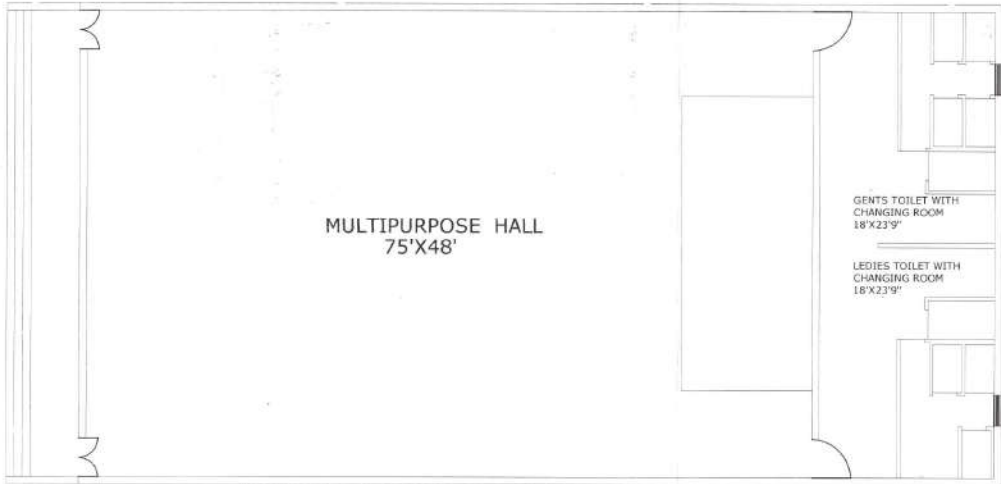

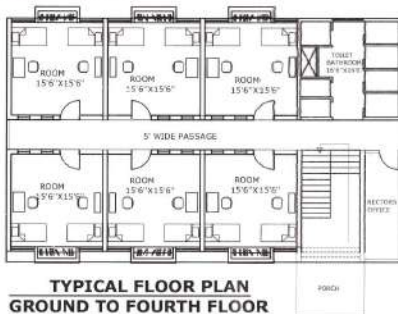

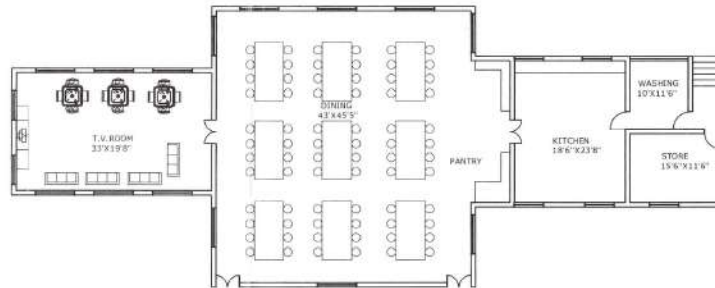


**TYPICAL FLOOR PLAN
